
Legal basis	Packaging Act No. 477/2001 (Zakon 477/2001 Sbirky o Obalech) Regulation of the Ministry of Environment of the Czech Republic No. 641/2004	
Functionality of the system	Affected companies have the following obligations under the law: - Ensure the take-back and recycling or reuse - Participation in a dual system, licensing of packaging and keeping records of packaging types, quantity and packaging waste - Registration with the Czech Ministry of Environment - Annual evidence from the evidence management to the Czech Ministry of Environment The fulfillment of these obligations can be ensured by licensing the respective annual quantities with the dual system EKO-KOM. It is the only system currently licensed in the Czech Republic. With the commissioning of EKO-KOM, the obligations of the Packaging Act, including the registration and reporting obligations with the Ministry of the Environment, are fully transferred to EKO-KOM. Manufacturers who place less than 300 kg of packaging on the market per year and whose annual turnover at the same time does not exceed CZK 4.5 million (approx. € 173 thousand) are exempt.	
Responsible	Person responsible for placing packaging on the Czech market (manufacturer, importer, distributor).	
Affected packaging	Obligation to take back all packaging placed on the market or in circulation in the Czech Republic (B2C packaging); B2B packaging is exempt.	
Financing/disposal	A registration fee of CZK 800 is payable for registration in the Initial Distributor List at the Ministry of Environment; a registration fee of the same amount per year is payable for registration in the list in subsequent calendar years.	
Reporting requirement	 Quarterly statements of the quantity of packaging placed on the market Quarterly remuneration for the services provided for the take-back and recovery of packaging waste Payment of an annual fee Connection to the system: payment of a quarterly and fixed fee 	
Non-compliance	Fines of varying amounts imposed depending on the severity of the violation.	
Special features of online trading	The registration and licensing obligations also apply to all online retailers. Shipping cartons are also subject to the recycling obligation.	
Special features for foreign companies	Foreign traders who ship to customers in the Czech Republic are affected by the Packaging Act and its obligations.
